9. If Client cancels this contract for any reason, the deposit will be returned less a \$20.00 handling fee. There will be a \$30.00 charge on all returned checks or stop payments.
10. Please arrange in advance at least a 7' by 7' space for the DJ and also a 6-foot table for the DJ's use.
11. Collective Moods DJ, LLC cannot be held liable for any injuries occurred during the event.
12. Payment by check, money order or cash accepted. (Sorry we do not accept credit cards at this time).

13. If the event is to be held outdoors, it will be the responsibility of the client to provide a raised staging area and tent covering to protect all equipment from direct sunlight and precipitation.
14. Guest shall not be allowed in the equipment setup area prior to or during the event unless invited on stage by the DJ/MC. This is solely for the guest's personal safety and to alleviate inadvertent damages to equipment that could occur. Safety personnel should be aware and enforce this "off limits area."
15. Access to a locking private changing room shall be provided for the DJ/MC. This room shall be available after system setup and prior to the start of the event so the DJ/MC can change into appropriate attire. (Not needed when early setup is arranged)
16. Access to the building for equipment setup shall be available when needed by the DJ/MC. Typically the DJ/MC will arrive 2 hours prior to the start of the event to setup and test equipment. Therefore, special arrangements may be needed should other clients or events occupy this room or if guest will be arriving prior to the DJ/MC. The DJ/MC cannot setup equipment or move equipment when the room is being occupied. Please list the contact information for the facility below.
